Entry deadline – Late entry fee of \$10.00 extra for entries postmarked after March 9, 2012 (so that we can adjust schedule if needed). (**SEND CHECKS TO MARTY SCHNORF AT P.O. BOX 183 CHARLESTON IL 61920**)

Directions-Mattoon is just off I-57, 45 miles south of Champaign and 10 miles west of Charleston. Take the Rt. 16 exit west (which later becomes Charleston Ave.) towards Mattoon at mile marker 190 on I-57. Go west approx. 3 miles to 17th St. and turn (north) and go about 3 blocks. The YMCA is on the left.

Lifts-Two hands snatch and two hands clean and jerk

Sanction- This meet is sanctioned by USA Weightlifting and the Central Local Weightlifting Committee, Sanction #21-12-03 (**ALL LIFTERS MUST BE MEMBERS OF USA WEIGHTLIFTING. LIFTERS MUST EITHER REGISTER WITH USAW AT THE MEET OR ELSE SHOW PROOF OF MEMBERSHIP AT THE MEET.**)

Divisions-Male and Female – 13 & under, 14 & 15, 16 & 17, 18-20, Open (21- 34), Masters 35 – 39, 40 – 44. 45 – 49, 50 – 54, etc. (Note – if there is enough interest we might add a division for Crossfit members.

Classes- Jrs., Open & Masters – Male (in kgs.) 56, 62, 69, 77, 85, 94, 105, 105+

Female-Jrs., Open and Masters (in kgs.) 48, 53, 58, 63, 69, 75, 75+

Males- 13 & under (in kgs.) 35, 39, 44, 50, 56, 62, 69, 69+, 14 & 15 – 44, 50, 56, 62, 69, 77, 85, 85+, 16 & 17- 50, 56, 62, 69, 77, 85, 94, 105, 105+
